## **Report of the Directors and Trustees**

The trustees (who are also the directors of the charitable company for the purposes of the Companies Act) present their combined directors' report and trustees' report, as required by company law, together with the audited financial statements of Endometriosis UK (the Charity) for the year ended 31 March 2019. The trustees confirm that the trustees' report and financial statements of the Charity comply with the current statutory requirements, the requirements of the Charity's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

## **Legal and administrative information**

Endometriosis UK is a registered charity and a company limited by guarantee, governed by the company's memorandum and articles. All the directors of the company serve as trustees of Endometriosis UK. Full legal and administrative details are set out on page 3.

## **Principal objectives and activities**

The principal objectives and activities of Endometriosis UK are:

- To provide support and information services to women with endometriosis.
- To advance the education of the general public and health professionals regarding endometriosis.
- To promote research into the disease.

The following outcomes for 2015 – 19 have been agreed:

1. Better quality of life for women with endometriosis.
2. Better healthcare for women with endometriosis.
3. Increased public and political awareness of endometriosis in the UK.

## About endometriosis

Endometriosis is a gynaecological condition where tissue similar to the lining of the womb grows in other areas of the body, most commonly within the pelvic cavity. This tissue responds to the hormonal cycle in the same way as the lining of the womb, but unlike the lining of the womb there is no way for it to exit the body. It remains within the body where the bleeding forms lesions, cysts and scar tissue (adhesions). An estimated 1.5 million women in the UK have endometriosis - that's 1 in 10 from puberty to menopause who suffer from this disease, although the impact may be felt for life. We do not know the percentage severely disabled by it. We currently do not know what causes the disease and there is no cure.

Endometriosis can result in inflammation, scar tissue, severe pain, painful sexual intercourse, infertility, bowel and digestive problems, bladder problems and a wide range of other symptoms. None of the symptoms are exclusive to endometriosis and, despite being the second most common gynaecological disease, diagnosis can take a long time often with multiple visits to healthcare practitioners. Currently surgery is the only way of diagnosing it definitively. Endometriosis UK's own patient surveys have found that on average it takes 7.5 years from first symptoms to being diagnosed (January 2011). Whilst this is an improvement upon the 2005 survey (11 years of delay), it is still unacceptably long. Additionally, there is a general lack of awareness about it: fewer than 50% of people asked in a survey (February 2013) were aware of the condition and even fewer knew what it was.

There is no wholly satisfactory drug therapy and often the treatment is surgery, although for many this has to be repeated. The repercussions can be enormous: it can affect every aspect of a woman's life, from work, ability to conceive, to relationships and overall quality of life. Since the condition is hard to see and problematic to diagnose, women can often feel very isolated - coping with persistent pain, infertility and other unpleasant symptoms can also lead to depression.

Endometriosis can also have a huge effect on partners, family members and personal relationships, and all those affected may need support. This is evident from the number of partners and family members who contact the charity. Although in the past it was considered a disease of women aged 30+, increasing numbers of women are reporting that they are experiencing troublesome symptoms as early as their first period and sometimes even before this. There is no evidence to suggest that this is due to an increase in occurrence of endometriosis, but rather is due to the realisation at an earlier age that severe period pain is not normal. Hence younger women are seeking help at an earlier age - something for which the charity's campaigns over many years should take credit. However, without improved diagnosis and treatment the negative outcomes for women of persistent pain, debilitating symptoms and potential infertility still remain.

## FOREWORD

This year has seen significant changes in awareness and policy-making that will make real and tangible differences to the lives of those living with endometriosis and for future generations.


One of our proudest achievements has been the success of our campaign to introduce compulsory menstrual wellbeing education for all primary and secondary schools in England from 2020. This was announced by the then Education Minister Damien Hinds MP in February 2019, following campaigning by us and our partners. Thank you to everyone who signed the petition and shared their own stories with the #WhatIWishILearned hashtag on social media. We are now working to ensure that menstrual wellbeing will be taught in schools across the UK – not just England - as understanding what a normal menstrual cycle is like and when to seek help is a key component in our aim of reducing diagnosis time.

Improving care and treatment for endometriosis remains one of our key priorities. GPs have an important role to play in this and we are delighted to see our long-term drive to support GPs with diagnosing endometriosis come to fruition with a partnership with the Royal College of GPs. A [Menstrual Wellbeing Toolkit](#) has been launched on the RCGP website to help GPs with earlier diagnosis of the endometriosis, and in March this year an e-learning module on endometriosis for GPs was launched. The launch of the NICE [Quality Standards for Endometriosis](#) in August 2018 offered a key opportunity to improve care and treatment, and we were pleased to see our comments taken on board. We are now working to ensure that these guidelines are implemented across the UK so everyone has access to the right care at the right time.

Another highlight of this year was the *Endometriosis Research Now!* Conference, the first endometriosis scientific research conference for those with endometriosis, families and friends, with top researchers from around the world sharing their latest research with 300 delegates.

We were also delighted to announce our partnership with Standard Life to help raise awareness of endometriosis and inspire change within the workplace. As part of the partnership, we were proud to be part of the Standard Life [Beyond the Invisible exhibition](#) with internationally renowned photographer Rankin to shine a light on the condition during Endometriosis Awareness Month in March 2019. As a result of the partnership, endometriosis has been spoken about by all major news channels and our message has reached audiences we have not reached before.

We have bold and ambitious plans for the future. We are developing a new strategy for the coming 5 years, built on a strong sense that people with endometriosis deserve better and now is the time for change. We are determined Endometriosis UK will do more to bring about the changes that those with endometriosis need – in diagnosis times, in the workplace, in education and in ensuring everyone gets better treatment and support to live well with the disease. But we know that we cannot bring about this change alone and that this will be a team effort. So a huge thank you to everyone who is part of Team Endo – members, volunteers running our support services and in other roles, everyone who has run or cycled or baked cakes and those who supported them, healthcare professionals, staff, trustees, researchers and especially people with endometriosis and their friends and families who offer their support. We look forward to working with you in the coming year.

## KEY ACHIEVEMENTS

In 2018/19 we achieved several long-term objectives, focused on reducing diagnosis times and supporting those with endometriosis. We have pulled out a few of the highlights of the year below, with more details of our activities on following pages.

### ✓ SUPPORT FOR PEOPLE LIVING WITH ENDOMETRIOSIS

The very heart of what we do is support those living with endometriosis, providing direct support through our network of Support Groups, Helpline and Health Unlocked our online forum. All are run by an amazing team of volunteers, and a huge thank you to all those who give up their time to do such great work. Our Support Groups are the face of Endometriosis UK for many, and the year saw 7 new Support Groups launched taking the total to 39, with over 250 meetings held during the year, and a whopping 9,000 new people signed up to Health Unlocked, our online forum.

This year our partnership with the Royal College of GPs (RCGP) for a Menstrual Wellbeing spotlight project resulted in two significant new resources for GPs: a *Menstrual Wellbeing Toolkit* and an endometriosis e-learning module. We believe that these tools, along with increased awareness, will help GPs support earlier diagnosis of the disease.

### ✓ INFORMATION & RESEARCH

*Endometriosis Research Now!* was our – and the UK's – first ever scientific research conference for those with endometriosis, friends and family. Working in partnership with the World Endometriosis Society, and World Endometriosis Research Foundation we had world class researchers speaking to a packed and sold out event. Thanks to generous grant support from the Wellcome Trust we were able to keep delegate fees low, and to offer some travel bursaries to the unwaged. A big thank you to the research community for their support and engagement.

### ✓ CAMPAIGNING

With your help we did it – we got Menstrual Wellbeing added to the new school curriculum for primary and secondary schools across England. Over 100,000 people signed our petition calling for this, 100's of people shared their experiences on social media, we gained the support of the All Party Parliamentary Group (APPG) on Education, and had two meetings with the Minister; you can imagine all the work behind the scenes. A great outcome, as from 2020 all primary and secondary school children will be educated in an age appropriate way about menstrual wellbeing and what is a 'normal' period, and what is not.

### ✓ RESOURCING

We were delighted to launch our corporate partnership with Standard Life, working together to raise awareness, reduce diagnosis time, and tackle stigma in the workplace. Standard Life are keen to champion Invisible Illnesses and it is great for us and for all those with the disease that they have chosen Endometriosis UK as their first partner. It is unusual for such a large company to work with a small charity, and we are impressed with Standard Life for all the work they have put in not just in how to champion Invisible Illnesses but also in how to work supportively and in partnership with us to achieve our goals.

## SUPPORT FOR PEOPLE LIVING WITH ENDOMETRIOSIS

### Highlights

- ✓ Launched 7 new Support Groups, with 39 Support Groups running across the UK. Over the year 260 support group meetings were held including 9 of our online support group meetings.
- ✓ Supported and trained 36 new volunteers to run our Support Groups, Helpline and online forum Health Unlocked.
- ✓ Increased the support offered via Health Unlocked, our online moderated forum, with 9,000 new members signing up over the year taking the total to over 40,000.
- ✓ Developed our helpline and answered 515 calls.
- ✓ Hosted two *Living with Endometriosis* information days in partnership with BSGE Centres, Edinburgh and London, to improve knowledge and understanding of living with endometriosis.
- ✓ Secured funding from the Scottish Government to expand our reach in Scotland.
- ✓ Partnered with the Royal College of GPs (RCGP) to launch a *Menstrual Wellbeing Toolkit* and an endometriosis e-learning module for GPs, as part of a *Menstrual Wellbeing* spotlight project, helping GPs support earlier diagnosis of the disease.
- ✓ Contributed to and supported the launch of the NICE Endometriosis Quality Standards.

### Future Plans

- ✓ Investigate development of the Helpline to provide email support, in addition to the current telephone service.
- ✓ Review with our Support Groups how they would like to develop to support the needs in their communities.
- ✓ Open 6 new Support Groups in areas where we have identified there are gaps in provision plus a new online support group for rural Wales given the transport challenges.
- ✓ Analyse trends of Helpline calls and recruit volunteers to do shifts where call volumes are higher so we can answer more calls.
- ✓ Continue to develop a programme of *Living with Endometriosis* information days in partnership with BSGE centres across the UK.

### Highlights

- ✓ First ever scientific research conference for those with endometriosis, family and friends - *Endometriosis Research Now!* The sell-out event was organised in partnership with the World Endometriosis Research Foundation and World Endometriosis Society and received excellent feedback from those attending.
- ✓ Partnered with Universities and Research Consortia across the UK to support Public and Patient Involvement (PPI) in a range of research projects and support funding applications to increase the amount of research into endometriosis.
- ✓ Continuing development of website, with over 400,000 unique users visits over the year.

### Future Plans

- ✓ Hold our second *Endometriosis Research Now!* Conference, in Scotland.
- ✓ Work with the research community on projects to learn more about endometriosis, its treatment and management, focussing on the needs of those with the disease.
- ✓ Continue to push for increased funding into research.

## AWARENESS & CAMPAIGNING

### Highlights

- ✓ Successfully campaigned for the introduction of menstrual wellbeing education in all primary and secondary schools across England from 2020.
- ✓ Member of the Welsh Government Endometriosis Task and Finish Group, which produced a report on improving care for endometriosis in Wales.
- ✓ Increasing our work with Government: worked with the Women's Health All Party Parliamentary Group (APPG) in Westminster, and the Cross-Party Groups for Women's Health in Scotland and Wales to continue to raise awareness of endometriosis with Governments. Held events during Endometriosis Awareness Month in the Scottish and UK Parliaments to secure the support of politicians.
- ✓ Increased impact of and participation in Endometriosis Awareness Month, held in March. We were delighted to partner with Standard Life for their *Beyond the Invisible* exhibition with internationally renowned photographer Rankin to shine a light on the disease. Extensive media coverage meant many more people heard about endometriosis on TV, radio, in the press and online.
- ✓ Supported participation in the Worldwide EndoMarch events in Glasgow, Cardiff and Llandudno (in partnership with FTWW), Belfast, and London.
- ✓ Achieved high profile coverage raising awareness of endometriosis across all major news outlets.

### Future Plans

- ✓ Increased public awareness through a programme of annual campaigns.
- ✓ Continue to campaign to get menstrual wellbeing included in the school curriculum in Wales, Scotland and Northern Ireland.
- ✓ Proactively working with journalists to raise awareness.

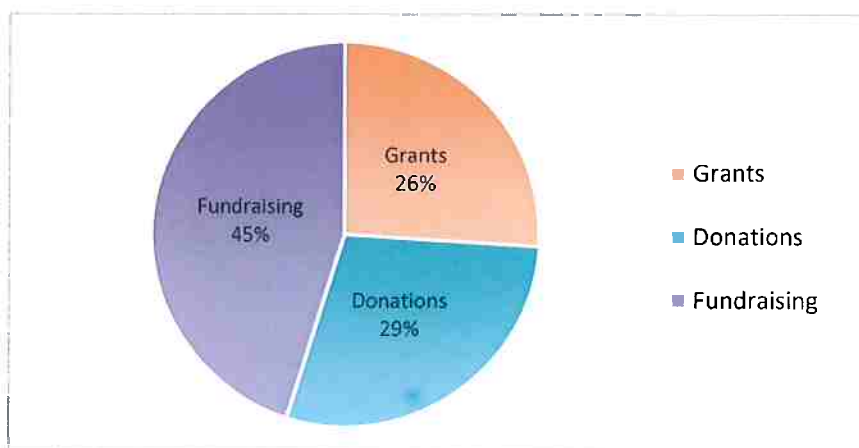

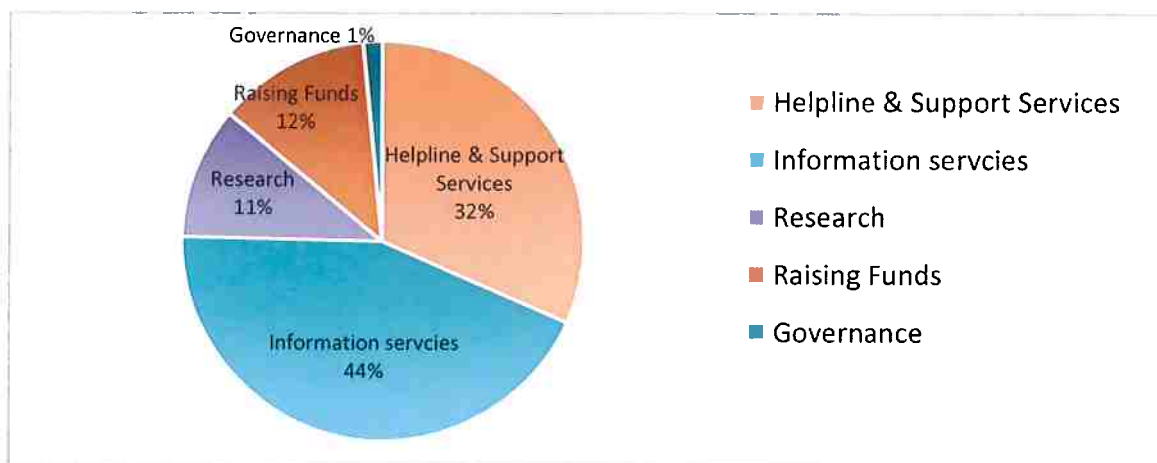

## **GOVERNANCE**

### **FINANCIAL**

The trustee board oversees the charity's finances. To support the Board, a Finance Committee meets regularly, chaired by Treasurer Amanda Collier who is a qualified accountant and Senior Manager at PwC.

The year 2018-19 ended with a surplus of £50,000, following a surplus of £66,000 in 2017/18, a surplus of £90,000 in 2016/17 and a deficit of £31,000 in 2015/16. As well as increasing our expenditure we were able to post a surplus as a result of careful management of costs and planned investment which delivered in this year. The Trustees were keen to secure income streams to ensure that we are in a place to develop our plans – ambitious plans for a small charity. Through both managing costs and developing our fundraising, the trustees carefully monitored finances over the year to ensure the year ended with unrestricted reserves that comfortably met our reserves policy. The Trustees, and Finance Committee working closely with the CEO, will continue to look for opportunities to develop further fundraising opportunities.

### **RESERVES**

Our reserves policy is to achieve unrestricted reserves equivalent to 3-6 months' operating costs. Reserves level at March 2019 were 9 months operating costs. Our reserves have enabled us to deliver a planned increase in our operating costs over the year as we expand our activities, investing towards the end of the year in two new staff positions to support awareness raising, campaigning and supporter development. Staff and Trustees carefully monitor the cash flow position and reserves. Whilst building reserves has proved to be challenging in the current economic climate, our fundraising plans – combined with hard work and the generosity of all our donors – have helped us achieve our reserves target. At the year end, the charity has unrestricted reserves totalling £223,526.

Having sufficient reserves allows us to plan for and deliver future projects, with a focus on decreasing diagnosis times, raising awareness and supporting those with endometriosis. It also enables us to leverage further income, for example some funders are happier to part fund activities that the organisation has already raised some money for. Having sufficient reserves allows us to make the most of these opportunities.

### **PUBLIC BENEFIT STATEMENT**

The Trustees confirm that they have complied with the duty set out under section 4 of the Charities Act 2006 to have due regard to the Charity Commission's guidance on public benefit 'Charities and Public Benefit' in developing the objectives for the year and in planning activities.

## **RISK**

The charity reviewed risk during 2018-19, covering the key aspects of our work including finance, governance and management, operational and external factors. Material risks were identified, reviewed and mitigated by the trustees and this will continue in the year ahead.

Our work depends on the time and knowledge kindly offered to us by our volunteers, fundraisers, speakers, health experts and clinical advisors. Without them we would not be able to reach and support the people we do. We would like to thank them all for their on-going support and generosity. All those volunteers who have given up their time to support other women with endometriosis - through the Helpline, Support Groups, Health Unlocked moderators - receive a special vote of thanks. Huge thanks as well to everyone involved in running an event as part of Endometriosis Awareness throughout March and everyone who baked cakes or ran or walked or gave up chocolate (or sponsored others for doing so) or were involved in other fundraising projects to raise money to support the charity. And a very heartfelt thank you to those who told their stories to the media to raise awareness, which can be such a hard and emotional thing to do yet is vital in raising awareness and helping others.

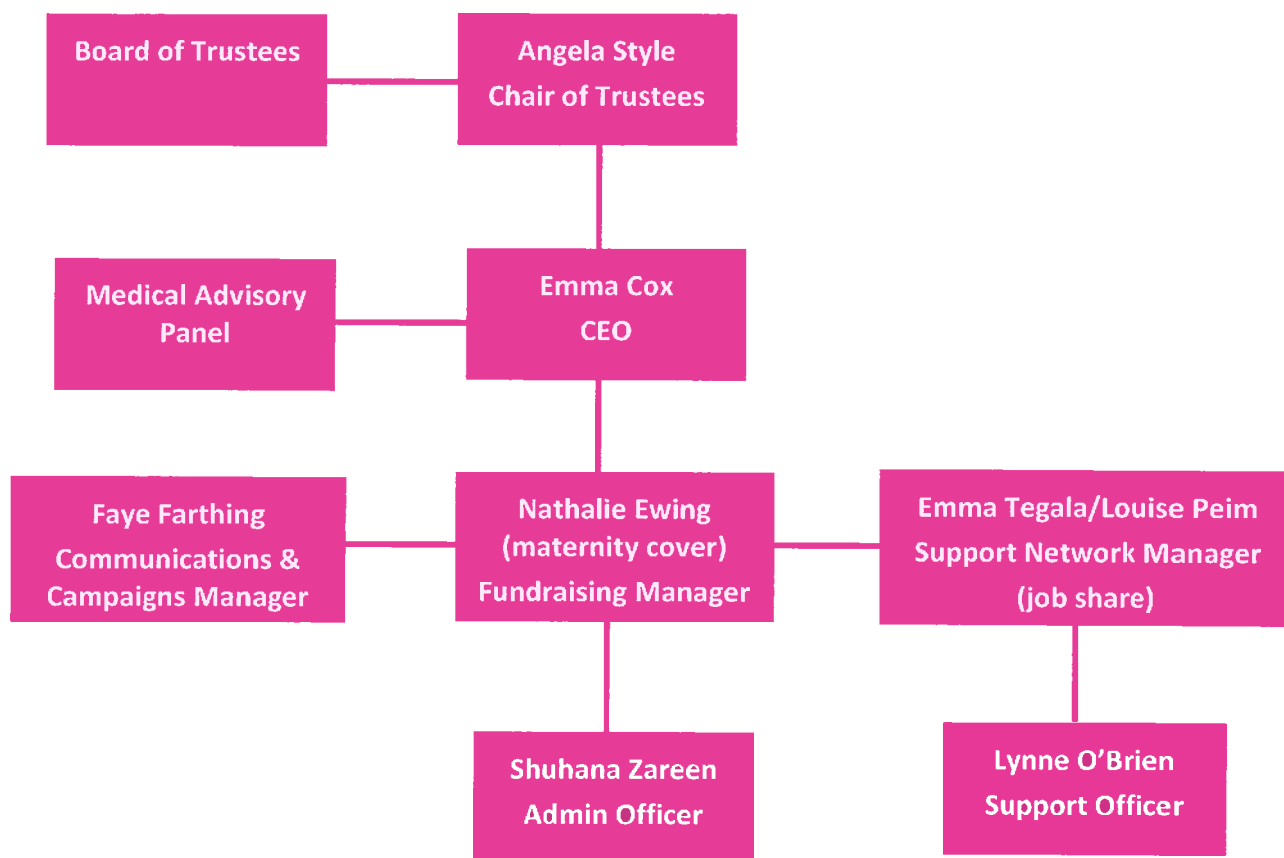

#### STATEMENT OF TRUSTEES RESPONSIBILITIES

The trustees (who are also the directors of Endometriosis UK for the purposes of company law) are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland".

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing those financial statements, the trustees are required to

- select suitable accounting policies and then apply them consistently
- observe the methods and principles in the Charity SORP
- make judgements and estimates that are reasonable and prudent
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial statements comply with the Companies Act 2006. 
The auditors, Knox Cropper, will be proposed for re-appointment at the forthcoming Annual General Meeting.




